- 3. Investor needs to ensure that the details mentioned in the TIDCWP Cancellation form are correctly filled in. In case of any ambiguity the TIDCWP Cancellation form is liable for rejection either at the collection point itself or subsequently after detailed scrutiny / verification at the back office of the Registrar.
- 4. In case of joint holders in the folio the form needs to be signed by either one of the holder or all the holders depending upon the mode of holding.
